



CAPACITY LIMITS:

- (1) Indoor – Up to 150 guests may enjoy full use of the meeting space if vaccinated or tested/ 3 households if not vaccinated or tested.
- (2) Outdoor – Up to 300 guests may enjoy full use of the meeting space if vaccinated or tested/ 100 if not vaccinated or tested.

Proof of Protection:

- (1) Meeting planner or Designee must verify attendees are fully vaccinated (> 2 weeks post final dose) or negative COVID test (PCR test taken within 72 hours of event or antigen test within 24 hours of event).
- (2) An Attestation Form must be signed and submitted to Pebble Beach Company acknowledging all attendees were verified.
- (3) Meeting planner or Designee must hold copy of vaccine card, photo of vaccine card and printed document from test provider/lab showing negative results from all attendees

Attendee Guidelines:

- (1) Assigned seating.
- (2) No cocktail receptions.
- (3) No self-service of drink including walk-up bars (service bars only).
- (4) No Self-Service of food (plated meals preferred; buffets require service attendants).
- (5) Mandatory face coverings except when seated and eating or drinking.
- (6) Live music allowed but no dance floor.

Effective April 15, 2021, the State of California and Monterey County have implemented mandatory operational standards (the "Order"), which allows for certain activities, including private events. As a condition to hosting a private event at Pebble Beach Resorts ("PBR") and in compliance with the Order, I, _____, on behalf of the Event Host(s), personally verified and confirmed the full vaccination or negative COVID test status and actual attendance of each listed guest, as follows:

- I viewed each guest's actual or digital record of completed vaccination card, showing the guest's name, name of the administered vaccine, and date(s) of administered vaccine(s). I confirm that each listed guest has received their final inoculation at least 2 weeks prior to the Event, OR
- I viewed each guest's actual or digital record of negative lab results from a test provider or laboratory, showing the guest's name, type of test performed, either a PCR test (taken 72 hours from the Event) OR 24 hour antigen test (taken 24 hours from the Event), and the date of the negative test results, and
- I confirm that each listed guest was present at the Event.

Failure to personally verify and confirm the full vaccination or negative COVID test status of each guest in attendance may result in postponement or cancellation of the Event, at no fault of PBR.
